The Special District For Perry Park Ranch

Thank you to everyone who participated in our second slash pickup and final one for 2022. We will resume the slash pickups in 2023. We also appreciate the increased participation by Perry Park residents in our Board of Directors meetings and topics. For our larger grant program, the fire mitigation work in the Upper Cheyenne area is finishing up its current phase, and will then be entering Phase 3 with removal of dead and dying timber in 2023. During this phase, you will start seeing helicopters clearing the area. We've also applied for additional grants to continue our major programs. In order to qualify for grant matching in our fire mitigation programs, a portion of resident homeowner participation is required. The more resident participation we can demonstrate, the more grant money we can request for major programs!

Due to his upcoming move out of the neighborhood, Chuck Wagner resigned from his position on the Board of Directors effective November 10th, and Bonnie Schwam was appointed to fill his seat until the 2023 elections. In 2023, three positions on the Board of Directors will be up for election.

Other current topics on the board include:

- 2023 Budget will be completed in December.
- Gateway Pond water rights there is a pending water court case where we are seeking approval of a plan to maintain water levels to the current levels on the pond.

- Gilloon Pond improvements we are seeking Douglas County support for improving this natural area
- Hay Cutting and Weed Spraying we are still seeking an effective hay cutting and weed spraying solution for the Big D and front neighborhood areas.
- Upper Cheyenne access we are working with Douglas County to transition access control of this area to the County.

Our December board meeting is scheduled for Thursday – December 8, 2022, at 6:00 p.m. at the Perry Park Country Club and on Zoom. You can see the meeting schedule and documents, as well as other neighborhood information and contact forms, at <a href="https://www.perrypark.org">https://www.perrypark.org</a> - Zoom and in-person attendance are options, making it convenient for you to participate. We hope to have you there. We also have committees and we would welcome more volunteers. There are many great ideas for improving our community and to implement more of them we need you!

# Fire Marshal Randy Johnson (RJ) retires from Larkspur Fire Protection District (LFPD)

Having served the LFPD for 27 years, Randy Johnson retired on October 31st. He started as a volunteer firefighter in 1995 and became our Fire Marshall in 2002. During his time with the LFPD, he was involved in every aspect required of being a firefighter.

Over his years with the District, RJ is best remembered for his work in wildfire awareness and preparation measures. RJ individually met with many homeowners, walking their property and discussing measures to reduce their risks if fire were to move through. He played a significant role in Perry Park being designated as a Firewise Community and ongoing measures to meet the requirements of the program. Additionally, he was instrumental in the Community Wildfire Protection Plans (CWPP) for the Town of Larkspur,



Woodmoor Mountain, and Greater Sageport communities. Having these established programs will influence the continued insurability of homes within those high risk wildfire areas besides the improved chances of personal and property survivability. He also conducted the District's annual Community Wildfire Symposiums which focused on measures that homeowners may take in reducing their risks from forest fires. For his fellow firefighters, RJ greatly enjoyed being involved in wildfire training.

#### NEWS FROM THE WATER DISTRICT

"If we lived in a desert and our lives depended on a water supply that came out of a steel tube, we would inevitably watch that tube and talk about it understandingly. No citizen would need to be lectured about his duty toward its care and spurred to help if it were in danger. Those in such a community would develop a sense of public responsibility as to how that tube got built, how long it would last, how vital the intake might be if the rainfall on the forested mountains nearby ever changed in seasonal habit or amount. It would be a most unimaginative person, or a stupid one, who could not see the vital relation between the mountains, the forests, that tube and himself."

The Board met for the regular meeting on November 9, 2022 at 2:00 pm.

Minutes of the October 4, 2022 special meeting and October 20, 2022 regular meeting were reviewed and approved. Disbursements of \$200,876.59 were presented, reviewed, discussed, and approved by the Board.

The Board reviewed the District's Monthly Staff Report prepared and submitted by District Manager, Diana Miller. Detailed responses to all questions and inquiries were satisfactory.

The District's Systems Report, compiled by Will Parker, Semocor Inc., was then presented. Answers to all questions and inquiries by the Board were deemed acceptable.

The proposed budget for 2023 as modified by the District Manager, was presented to the Board for further review and adjustment. Specific line items were noted, reviewed, questioned, and clarified.

The final budget compilation will be presented to the Board for approval at the December meeting.

Other items on the agenda:

Gravel pit lease agreement with the PPMD. Water taps - Perry Park Entry - Jill Arthurs. Security reduction request. – Brett Patrick Phoenix Feasibility Study - Garry Lawrenz Echo Village Feasibility Study.

As a reminder, the regular meeting December 14, 2022 at 2:00 pm. to further consider increases to the District's water, sewer, and other rates, along with tap, development, and other fees, is open all interested parties for comment (as was the November regular meeting).

There being no further board member discussion, the meeting was adjourned. Further information is available on the district website, www.ppwsd.org.



#### **Holiday Plants**

The holiday season is here and you can walk into any garden center, home improvement store, or grocery store and see holidays plants. Poinsettias, Holiday Cacti, and Amaryllis can put gardeners in the mood to buy and maintain one or all of these. And because it's winter, we crave something that is blooming!

#### IDENTIFYING HOLIDAY CACTI



If you've recently purchased a holiday cactus, or you have had one for years, you may notice that it has, or will bloom about the same time every year. If yours is in full bloom now, you may have a Thanksgiving cactus, if it blooms in December, a Christmas cactus, and in the spring, an Easter cactus. The difference is in the shape of their leaves and flowers.

A Thanksgiving Cactus has stems that grow upright and may arc. Their segmented stems will have 2-4 pointed edges. Christmas Cactus stems are breakable have smooth, round edges, and hang down. An Easter Cactus has tubular flowers and segmented round leaves.

To get your cactus to bloom, allow it to have time in the dark when the buds are forming. Each cacti likes welldrained soil and as with most succulents, wait to water until the soil is dry.



Amaryllis comes in many beautiful colors and different bloom shapes. You can buy them either already planted, or as a plain bulb. Cover your roots and about a third of the bulb in welldrained soil and place in a sunny



spot. After it blooms, and dies back a little, cut the stalk about 2 inches above the bulb. Store in its pot in a cool dark space. Bring it out next year to bloom again!

Poinsettias can have either the popular red flowers, or

white or pink and can last up to three or four months. I've also known gardeners who keep them alive longer and may even get them to bloom again the following year. They will however lose their ornamental value as leaves drop after the first bloom. They like bright



sunlight, and an evenly moist soil.

In this last article of the year, I wanted to recommend some interesting books that I've enjoyed during our down gardening time. Each would make a great gift.

Two Gardeners by Katherine S. White & Elizabeth Lawrence

This book is a collection of letters sent from 1958-1977 documenting the friendship and gardening experiences of two grown women.

Why We Garden: Cultivating a Sense of Space by Jim Nollman

Coming from a different garden perspective, the author takes you month by month through the art of gardening and cooperating with nature.

The Language of Flowers by Vanessa Diffenbach

This is a fiction story about a foster child whose first real connection is to flowers and their meanings. This story has stuck with me since I read it in 2018.

Marcy has always been a sponge for knowledge as a lifelong learner. She never


met a stranger. If you had a need she not only helped you with that need, you left having resources for continued assistance.





#### **Larkspur Fire Protection District - History and Outlook**

#### The Past

The Larkspur Fire Protection District (LFPD) was born out of necessity in 1963 after a large fire north of the Tomah Road campground threatened the community. Individuals dedicated to protecting their community answered the call and established the district. The City of Fort Collins donated the first fire truck, which consisted of a 200-gallon tank and a low-capacity pump mounted on a 4x4 military pickup. The LFPD strives to be worthy of the dedication and sacrifice of those who came before.

Initially, the LFPD was staffed almost entirely by volunteer firefighters who resided in the district and responded from their homes to one of four fire stations. A time of change came in 1997 when commercial

ambulance services were no longer available to provide timecritical advanced life support and emergency transport services. The district adapted by hiring firefighters and paramedics and eventually staffing



three shifts with paramedics at two stations. The main station, designation 161, in Larkspur was upgraded in 2010, providing additional individual living quarters, administrative offices, storage and mechanical areas, and a firefighter gymnasium. The Perry Park station, designation 162, was also upgraded to provide similar accommodations.

#### The Present

A publicly-elected five-member Board of Directors governs overall functioning of LFPD as fiduciaries for the citizens in the District. The current board includes two retired LFPD volunteer firefighters and three community members who have stepped forward.

The Fire Chief is responsible for the operational aspects of LFPD. In addition to Shift Captains, the Fire Chief supervises a Fire Marshal, a Training Officer, an Administrative Assistant, and a part-time accountant. LFPD is unique if compared to larger fire service agencies, as our Fire Chief also manages the functions that are usually assigned to specialists. These include budgeting, human resources, facilities management, legal, and information technology, to name a few.

Larkspur Fire currently employs 15 full-time firefighters and nine part-time firefighters. An officer, as Captain leads one of the three shifts, balancing resources between the two stations and implementing a diverse web of fire, medical, and motor vehicle accident training activities. When the call goes out, the Captain is first in command for the incident and requesting additional resources if needed. The district relies on volunteer firefighters to augment the paid staffing positions. A Volunteer Chief has provided critical operational and administrative support for many years, also supplementing the Fire Chief's role. The District recently funded, through a grant, a part-time grant administrator position. Grants are a vital contribution to the budget and administration of grants is an ongoing and timeconsuming process.

LFPD has a very active ongoing training program, which includes a firefighter academy for new volunteers. The program's roots reach back to the days of the resident

volunteer firefighters. The Training Lieutenant/Volunteer Coordinator orchestrates the training activities across the shifts and often leads the training. This position is also responsible for tracking the multiple certifications which each firefighter has achieved.

Over the years, many factors have led to a decline in active volunteer firefighters that live within the district (at this time we have only two). Current academy recruits tend to be individuals who are seeking a career in the fire service. They come from all walks of life and nearby Front Range communities. Larkspur Fire has a comprehensive selection process for academy recruits. Whether they graduate from the academy or are hired with experience, all firefighters are well-trained, certified and prepared to provide multiple facets of emergency services to the district.

With the completion of the I-25 Gap Project, the number of traffic accidents has significantly decreased, reducing our overall call volume along with the number of ambulance transports within the district. This has been a welcome result of improved highway safety on I-25. This reduced call volume does not reduce the number of staffed positions which are required on each shift. There remains a staffing level that is necessary to safely attack a residential structure fire, contain a wildfire before it spreads to homes, treat medical emergencies and respond to motor vehicle accidents.

#### The Future

Larkspur Fire will continue to face challenges. On the positive side, it has been decades since the district faced a major wildfire. This is due in part to good fortune, but also to the rapid response of our dedicated and skilled staff. Several of our firefighters deploy with wildland teams that fight wildfires from coast-to-coast and Alaska. They bring this experience back to the District, improving the capability to make an initial attack and coordinate outside resources as they arrive at the incident. The LFPD has long recognized wildfire fuel mitigation's importance and actively supported homeowners by offering educational seminars and onsite advice for residential protection against wildfire.

Larkspur Station 161 is fully staffed at all times with a minimum of a Captain, Engineer, Firefighter and a Paramedic. Our volunteers supplement this minimum staffing level. They will work, in their level of training capacity, at either station, during a shift just as paid personnel do. Perry Park Station 162 is staffed with an Engineer/or Firefighter and a Paramedic. It is a priority of LFPD to always maintain full strength staffing at Station 161. To accomplish this, Station 162 personnel may be temporarily shifted to Larkspur Station 161. As a result, the Perry Park Station 162 is currently staffed about 70 percent of the time. This is principally due to ongoing challenges in recruiting and retaining qualified firefighters and paramedics. LFPD must compete with larger and more lucrative fire agencies for personnel. We've made significant progress in offering competitive salaries for a fire agency of our size. A silver lining is that the graduates of the LFPD fire academy are a source of volunteer staffing and provide an experienced candidate pool for full and part-time positions.

Starting as the first LFPD Paramedic twenty four years ago, Fire Chief Stuart Mills intends to retire in January 2024. The Board of Directors has developed a hiring process to recruit a replacement and facilitate a smooth transition. The first phase of this process is to seek qualified candidates from the current staff. For day-to-day operational continuity, the Board of Directors is considering creating a Deputy Fire Chief position in conjunction with the hiring process. This position may be combined with the duties of the Fire Marshal and will not result in an additional full-time position.

From a financial perspective, the District appears to be in good standing for the next few years. But as the adage reminds us, "It is difficult to make predictions, especially about the future." How will current economic trends impact the District's residential property values and the corresponding revenue base? Will labor shortages continue to shrink the pool of qualified personnel, particularly in the Emergency Medical Services field? Will inflation increase operating expenses to a point that it out paces the District's revenue sources? The LFPD, with your support, is committed to meeting these challenges.

The community has overwhelmingly recognized the necessity of emergency services for public and personal safety and to protect property. This support has sustained the District through some lean times over the last six decades, and for this, we are thankful. We have always been in this together.

#### Wildfire and Embers

#### by Keith Worley, Wildfire Mitigation Specialist

It is estimated that 60-90% of homes lost to wildfires are ignited by embers, sometimes called firebrands. During major wildfires, typically pushed by high winds, a blizzard of embers is cast well ahead of the fire front. These do not rain down but instead are driven horizontally like snow in a blizzard.

What can you do to prevent these embers from igniting your home? Learn how to "harden" your home against embers. There are many tips at <a href="www.firewise.org">www.firewise.org</a> that describe techniques you can use to modify your home, and here are links to two helpful videos on Youtube:

- <u>"Your Home Can Survive a Wildfire"</u> by Dr. Jack Cohen.
- <u>"Tips to keep Homes from Igniting" by Michele</u> Steinberg

You can even take a short (and free) on-line training at the website called "Reducing Wildfire Risks to Property: Protecting Your Home or Business." There are also links to the Insurance Institute for Business and Home Safety (IBHS) research showing key areas of structures prone to ignition by embers. We can learn how to adapt our homes to the inevitable wildfire. Take time to learn these critical steps which, when combined with defensible space and home ignition zone fuel modifications, can improve your home's chances of surviving.

The Perry Park Metro District's Firewise Committee is planning to release its first draft of the Perry Park CWPP for public review. It will be posted on the PPMD website at <a href="https://www.perrypark.org">www.perrypark.org</a>. Be sure to sign up for notices.



#### **Perry Park Applies for Cost-share Grant**

Perry Park Metro District has applied for a costshare grant to assist homeowners with their wildfire mitigation. If awarded, the District will begin accepting applications from residents willing to meet the following criteria:

- Partner with two or more of their neighbors to unify their home ignitions zones per Colorado State Forest Service publication "The Home Ignition Zone: A guide to preparing your home for wildfire and creating defensible space" (go to www.csfs.colostate.edu to download).
- Complete a "structural ignitability assessment" and agree to implement measures to reduce ember ignitions.
- Must agree to implement fuel reduction work as recommended by a trained wildfire mitigation specialist.

There will only be a limited number of cost-share grants available. The proposed outcome is creation of "fire adapted" homes and surrounding ecosystems by using the latest science available. Homeowners abutting zones of vacant undeveloped lots are encouraged to apply. If the program is successful, PPMD will apply for additional funding. For a delightful change of pace, go to Park Meadows, shop till you drop, then relax for lunch or dinner at the Nordstrom Grill up on the 3rd floor of the store. Throughout the last 10 years, the Grill has undergone several changes, and the end result is a very comfortable atmosphere, extremely attentive waitresses, and a posh bar. They now have a fabulous chef and often a daily special. For example, on a recent Saturday



lunch menu, the features were Lamb Meatballs served with sourdough bread or a Lamb Burger sandwich with your choice of salad. All of their salads are absolutely outstanding. Of course, I always start with my favorite appetizer – Calamari with Aioli sauce, and theirs was excellent. The grill has an extensive wine list and often serves a special drink of the day. This time it featured a sparkling holiday libation with gin, cranberry juice and a sparkling soda! Much of the crowd was enjoying mimosas, and you often hear the frequent "pop" of the champagne bottles opening!

Now, for a very special treat, you must try the Bistro on 2nd Street in nearby Monument, a quaint bistro in an old Victorian house that has a casual and upbeat atmosphere with a very energetic wait staff. While not quite a 5-star Michelin, it comes very close. Unlike ordinary cafés, their menu is always changing according to the season. For example, during the summer months, you will find a salad composed of watermelon, blueberries, and strawberries dressed with a very light balsamic vinaigrette. Last week, one of the appetizers consisted of a lovely pumpkin/ cheese fondue served with nuggets of pork belly, chunks of lightly toasted French bread and sliced apples. A very favorite entrée of mine is the Pan-seared Chicken Saltimbocca served with sage, prosciutto, fontina, a side of summer squash, mashed potatoes and au jus. If the extensive wine list seems confusing, just ask your server what he/she recommends to pair with your entrée. If you go on a weekend, be sure to make reservations (719-480-8822). Also, if you have difficulty with stairs, please ask for a dining room on the first floor.

A must is a heated bird bath that can be used in winter or summer and the birds will LOVE you. All birds need water, so you end up sighting a plethora of species.

For nature lovers, there are a variety of reference books available – mammals and snacks, tracks, reptiles, butterflies, etc. Maybe a book on hiking trails in Colorado and the area. A butterfly net to get the birds out of your house. A gift certificate to one of the outdoor programs at Cherokee Ranch. A pair of binoculars come in handy for many purposes, or a spotting scope.

If the recipient of your gift is really adventurous, drop by the Denver Animal Shelter and pick up an unusual pet:

This picture will give you the chills. It looks like this bear is running straight at you. Imagine how the owner of the trail cam felt when he saw


this picture for the first time? How insane is it to catch a bear charging towards the camera?






to start the process for "inclusion" into the Metro District which would provide the new lots with the benefits of the Metro District and add them to the Metro District tax roll. Ground work has begun on the first phase of the infrastructure (roads, sewer, utilities) with twenty-six 1 to 1.5 acre planned for completion by next summer. The site is 49 acres and 30% will be retained as open space. A homeowner's association is planned for the development.

buildings top-out. When completed, the luxury complex set on a bluff, will offer




outstanding views of the foothills, and include many amenities – a fitness studio with separate yoga room,




