LARKSPUR – As Perry Park's wa-



ter and sewer infrastructure continues to age, Perry Park Water and Sanitation District is preparing for a November vote on a new bond issue that will fund a 10-year effort to bring all systems up to date (before they fail). Follow the PPW&S web site for more information so

you can make an informed VOTE for a much needed water and sewer system modernization.

CASTLE ROCK – PROMENADE – POT BELLY SANDWICH SHOP has its sign up along with **EUROPEAN WAX** and **SUPER CUTS**, all in the complex completing construction just north of Lowe's.

In the upper hill complex adjacent to Club Pilates, **POPCORN BLISS** is preparing to open It's gourmet with popcorn made on the premises, fine chocolates and bulk candies. Gift baskets are available. **TWENTY-FOUR HOUR EXERCISE** is getting closer and has its sign up too. After several delays since the original proposed Oct 2016 opening, the **KING SOOPER MARKETPLACE** is really going to open this month and will have a **US BANK** on the premises. Their recent challenge has



been finding enough employees to run the store. What about their old store (?) – **MURDOCH'S** is in the final stage of negotiations with plans to open in 2018 in the former King Sooper store after they complete renovations which include expanding the air conditioning to the whole store (only half now with product refrigeration cooling the remainder) and work on the basement (bet you didn't know they had a basement). Another building nearing completion in the restaurant complex to Lowe's south side with no tenants announced yet.



Demolition of the old Town Center Shopping Center kicks off the start of the new \$60 million **RIVERWALK** project

in the heart of Castle Rock and the Town is already well underway with their portion of the river walk public area

IN LOVING MEMORY:



The following memorial honors the extraordinary parents/guardians of Perry Park Ranch residents, Gerry Baker (Reatha) and Doug Vinton (Layne). Written by Ovid and Opal's family, the tribute was published in the *Denver Post* on April 16, 2017.

Ovid Martin (Curly) Baker, Nov. 8, 1920 - Oct. 19, 2015. "Curly" was born November 8, 1920, to

Ovid Martin Baker Sr. and Edna Fay (Dugger) Baker, in Glenwood Springs CO, the oldest of five siblings.

Opal Fern Baker April 11, 1921 - April 7, 2017. Opal was born to Effie and Evert Nokes in Meeker, CO the oldest of three siblings.

They met during their high school years at New Castle High School, (Colorado) and married (eloped), in May of their senior year, 1939. Together they happily shared over 76 years of marriage. As newlyweds they lived in Leadville, Colorado. They soon moved to Grand Junction where son Gerald Martin was born (1941). The family next moved to Denver where Ovid entered the Army Air Corp. to serve during WWII while Opal worked as a secretary at Western Beauty Supply.

In the 1950s, Opal supervised Ovid's building of their Littleton home, (a pre-cut lumber home), and maintained the home

fires while Ovid was flying the line for United Air Lines. Ovid's Captain bid required them to move to Elgin, Illinois, in the early 1960s. After a particularly cold winter in the mid 1960s, the couple moved to Los Altos, California. Soon after Douglas and Susan Vinton, nephew and niece, joined them in their home. In the summer of 1969 the family moved to Denver where Opal and Ovid remained for over four decades. In their later years, Ovid and Opal relocated to Castle Rock to be near their children.

Ovid enjoyed Lion's Club, the Rocky Mountains, photography, woodworking and a good meal. August was annually booked for Ovid' volunteer work at the annual EAA Fly-in event in Oshkosh, Wisconsin. Opal loved to garden, sew, enjoyed playing the piano, organ and listening to opera and classical music. She was also active with the UAL Flight Wives Association.

Ovid is survived by brother Jack (Baker) and brother-in-law Al (Robertson). Opal is survived by sister Jean (Nokes) Treweek, brother Glen Nokes. Both are survived by their son and his wife, Gerald and Reatha Baker, grandchildren Maren (Tom) Plisko, Corbett Baker, great grandchildren Kate and Claire Plisko, nephew Douglas (Layne) Vinton, niece Susan (Andrew) Walker, nephews James (Yvonne) Vinton, Richard (Claudia) Vinton, Gregory (Nancy) Vinton and many grand nieces and nephews who considered Opal and Ovid grandparents. Ovid, husband, brother, uncle, grandfather, great grandfather and friend was always ready for an adventure. He was bigger than life. Opal, wife, mother, sister, aunt, grandmother, great grandmother and friend, was a special woman loved for her commitment to family and devotion to Ovid. They will be greatly missed.

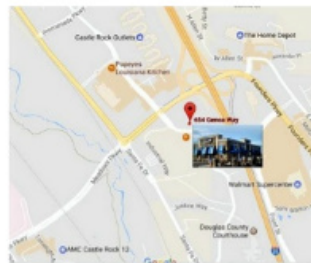
that ties in with the development and their expansion of the adjacent Town building.

Target makes room for a great fast food operation on the front corner of its parcel – directly across from the Chick fil-A. Planned for over a year, construction is now under way on a new **RAISING CANE’S CHICKEN FINGERS** freestanding restaurant. Founded in 1996 in Baton Rouge, they have grown to 310 locations in 23 states, Kuwait, Bahrain and Saudi Arabia. Their single entre is a top quality chicken finger served with their specialty Cane Sauce (secret recipe), French fries, Texas toast and homemade coleslaw from fresh red and green cabbage and sliced carrots



– makes my mouth water just writing about it. The wings are made to order, piping hot and fresh and bring a new flavor to town.

Still hungry? About a year ago, we said **CULVER’S RESTAURANT** was coming to Castle Rock. Finally they are undergoing the permitting process for their planed 4,207 square foot restaurant to be located on the lot adjacent to Arby’s, at 654 Genoa Way. Culver Franchising System, Inc., doing business as Culver’s, is a privately owned and operated fast casual restaurant chain that operates primarily in the Midwestern United States. The first Culver’s opened in 1984 in Sauk City, Wisconsin. As of March 8, 2017, the chain had 611 restaurants across the United States. Their menu includes a variety of choices ranging from their famous “Butter Burger,” chicken, fish and various sandwich choices, all served with very good French fries.



ENT CREDIT UNION is coming to town with two locations. Signage is up but no construction start yet for their building to be built directly across from the east end of the new Sam’s Club.

On the south side of town, their space is undergoing tenant finish at the old center anchored by the D C Library, Dairy Queen, etc. where they will be in the south end building behind the Valero Gas Station. As an ENT member, you are one of the owners of a not-for-profit financial cooperative, with 25 local service centers and 50 local surcharge-free ATMs. They are VERY competitive on vehicle loans.

PALMER LAKE – Driving by, I noticed the new little **STUB Restaurant** was open for breakfast and I gave it a try. Small but pleasant and has a nice outdoor deck in the rear. Limited but tasty menu – I enjoyed the Miss Piggy breakfast sandwich and my favorite, the country potatoes. Hamburger on the lunch menu. I will be back.



MONUMENT – The long overdue modernization of the **MCDONALD’S** is underway with major changes for the interior and exterior. Though challenging for access during the renovation, they are continuing to operate with entry via the playland door. Final finish will be quite modern. This has always been a very active, well located McDonalds and the new look will bring it current.



Downtown, the new **BLACK FOREST RESTAURANT** is now open in the former Shani’s space following several months of renovation. It is located in the middle of the Arts District at 140 2nd St. After they level the front patio, outside tables and an awning will be added. It is a combination café and deli with inside seating and a deli shop. Open from 6 a.m. till 7 p.m, so you can start your day with a tasty burrito or biscuits and gravy and progress up the menu from there.



The effort continues to develop the former **GLENEAGLE GOLF COURSE**. In 2009, approval was granted for a 47 patio home development on the former driving range. Westbrook Capi-

tal Holdings’ current plan is to build 56 single-family homes on 28-acres of the land leaving the remaining 73% of the golf course as open space. Still lots of matters to settle before a shovel hits the land, i.e. “300 year water supply rule”, drainage infrastructure and erosion control, but it is getting closer.



Adjacent to the Century Community new home development, Lake of the Rockies, the town is working with Gulf Coast Resorts on the **2.23 acres fronting on Monument Lake** which

will be divided into 6 lots for single-family residential. Lot size ranges from 13,260 square feet to 22,804 square feet. All six lots back onto Monument Lake and have a 50-foot rear setback with no boat docks or structures allowed. Access will be gated and

served by a private road called "Lake Vista Point."

The town has approved "temporary" pop-up vendors on a seasonal basis for **MONUMENT LAKE**. Adding to the summer activities at the lake you may be seeing boat rentals, summer supplies, and maybe some quick food for your day at the beach. This may carry over to winter ice fishing and ice skating activities as well. Vendors will be chosen on a lottery basis.

COLORADO SPRINGS – POLARIS POINT – Another tenant prepares to open in the new shops behind the Loaf and Jug. Pasadena-based **DOG HAUS BIERGARTEN** plans to expand from 21 stores in 19 states to nearly 500 stores across country over the next seven years. The Polaris Point store should



be open in the next 30 to 60 days and brings another flavor to the area – gourmet bratwursts! You can still get burgers, fries and shakes, but the dog/brat is really their specialty. A dog and a beer and fast service in a casual atmosphere. Expect to see more DHB's in our area in the near future.



A small but very busy neighborhood shopping center, **NORTHGATE VILLAGE CENTER** on Voyager at Middle Creek recently completed a 13-unit addition filling out the third and final phase of the development.

Three of the spaces have been leased with 10 to go. **FAMOUS AMERICAN BARBERHOP** is in the tenant finish stage and should be ready for customers in about 45 days. **PINOT's PALETTE** is a unique shop for those with an artistic slant where they provide art instruction while you create your masterpiece while enjoying a sip of wine – the more wine, the more interesting the creation. The other shop already packing the parking lot is **SUSHI ATO** where they state, "If you are looking for authentic homemade Japanese ramen, gyudon, teriyaki, tempura or are ready to enjoy fresh and exciting sushi created by our traditionally trained sushi chefs with over 95 years of combined experience at our 35 ft. long sushi bar, you have come to the right place!"

The Nevada Street Corridor in Colorado Springs is a fine example of how to do Urban Renewal right. From the continuing successes of the north end University Village-centered development, the newly proposed mid corridor urban plans run from the former Greyhound Race Track to the old K-Mart center at Fillmore St. and to the current activities at the **SOUTH NEVADA CORE**. Two developers have been extremely active in both building and preleasing while a third has shifted his activities further west due to the spiraling land cost in the area. The South Nevada Core consists of about 100 acres of former old hotels, retail and pawnshops along S. Nevada and S. Tejon between I-25 and E. Cheyenne Road about a mile south of the Colorado Springs central business district.

Quite a few buildings have already been razed with groundbreakings on several projects. The Harder-Diesslin Group where the Chief Motel and Stardust Lodge used to exist, the under construction



BROADMOOR SHOPS will include Natural Grocers, Zoe's Kitchen, Mad Greens and a Chick-fil-A which should all open later this summer. The Prime 25 two-level restaurant opened for dinner in January and the developer Ivy Group will start construction on 19 pre-sold condominiums, **CANYON CREEK TOWNHOMES**, this summer along with another 24-planned units. Having razed 40 building in the area, they also are planning a 110-unit branded hotel, and two apartment

projects totaling 180 units with a fall start in mind. They have also fully leased a to-be-built 9,000 square foot retail building scheduled for a summer start.

PIE FIVE PIZZA did not last long after opening at the Citadel Crossings and Briargate Promenade last year and closing both stores in February. They also closed their Longmont and Aurora stores. Lots of new pizza operations in the area and faced with the competition, these failed to generate enough business. Original plans called for 30 Colorado stores. Fortunately, the franchisee is doing better with its Colorado **FREDDY'S** operations.



The **GARDEN OF THE GODS complex** is undergoing a \$60 million expansion – true luxury \$\$\$\$\$. The 334-acre resort just east of its namesake park just completed a \$12 million International Health and Wellness Center and

recently commenced construction of 37 upscale cottages and villas at an estimated cost of \$48 million, targeted at their 2,500 club members. Pricing ranges from \$800,000 to \$3 million. The resort also includes 44 traditional hotel rooms, 12 suites and the 27-hole Kissing Camels Golf Course.

GENERAL RETAIL NEWS – The apparel slump continues and **JCPENNY's** is making big efforts to adjust. It is pushing beauty and home goods where consumers have been more



active and opening 100 plus appliance showrooms while at the same time closing 138 of its unprofitable stores. **PAYLESS SHOES** continues to lose sales to Amazon and has filed chapter 11 bankruptcy with plans to close about 400 of its 4,400 world-wide stores. **STAGE STORES** plans to acquire about half of the **GORDMAN's** 106 existing stores under its recently filed bankruptcy action. The **DARDEN** chain (Olive Garden, etc.) has acquired **CHEDDAR'S** adding 165 restaurants in 28 states to its expansive dining selections. Try their incredible Monte Cristo sandwich at the Cheddars on InterQuest Drive. **ALBERTSON'S** is in merger talks with **SPROUTS FARMERS MARKET**, which would add health foods to the Albertson's suite of Safeway, Vons and Shaw's supermarkets. The 131-year old **SEARS** chain is in a doubtful fight to stay alive as it closes 150 stores and sells off its **CRAFTSMAN TOOLS** to **BLACK & DECKER** who already owns DeWalt, Porter Cable, Stanley, Bostitch, Mac Tools, etc. Even **WALMART** is making adjustments as it eliminated 18,000 jobs over the past year following closures of non-performing stores. The good news is that they will hire 10,000 workers for their new store openings. The retail industry lost 30,000 jobs in the month of March!

MEMORIAL DAY: HONORING VETERANS
Michael Stone...

In the month of May, we have some special days. On May 14th, we will be able to honor our mothers on Mother's Day. On the 20th, we have Armed Forces Day, where we will honor those who are serving their country in one of our military service branches. May 29th is Memorial Day, where we honor those who have given their lives in service to the United States of America.



On Memorial Day, you may take time to remember family members, neighbors, relatives or friends who have made the "ultimate sacrifice" for this country. My

uncle, Richard W. Stone, served as a Captain in the U.S. Army and was killed during World War II. My dad, Edward L. Stone, was a Marine during World War II. Dad survived, which is why I'm here and able to write something in honor of his brother. But first, let me tell you about my dad.

Ed was born in 1920, and was the third child of nine in his family. The first child was James, who died as an infant. That left Dick as the oldest brother to everyone in his family. When World War II started, Ed volunteered for the U.S. Marines and served in the Philippines. He was on Bataan, where American Marines surrendered on April 9, 1942, but escaped the Bataan Death March by escaping with General Jonathon Wainwright, who took his men to the island of Corregidor. Although the Marines defended Corregidor against overwhelming odds, they were eventually forced to surrender on May 6th, 1942. Dad was forced into one of the "hell ships" and transported to a POW camp on the Japanese mainland. He spent the rest of World War II as a prisoner of war and was able to survive some horrible conditions to be able to return to the U.S. after the Japanese surrender in August 1945.

His brother Dick volunteered for the Army. As a young Lieutenant, he landed on Utah Beach in Normandy on July 9th, 1944. This was three days after "D-Day," so the beach landing was unopposed. Dick was in the 5th Infantry Division; 2nd Infantry Regiment, and the mission was "The Liberation of Western Europe."

From July to September, the 5th Division "Red Devils" fought for the liberation of France. On August 3, 1944, the 5th Division was assigned to the newly operational Third Army, under the command of General George S. Patton, Jr. By September 1st, Patton had moved his Third Army 700 miles to Verdun, France.

The Third Army was preparing to enter Germany after taking Verdun on September 1st, 1944. However, General Patton had advanced so far, and so fast, that he had outrun his supply chain. This halted all forward advance until they could get supplies of ammunition and gasoline. By September 6th, the Third Army was resupplied and ready to move eastward into Germany. While the Third Army was resting and waiting to be re-supplied, the German Army was able to prepare a strong defense on the East side of the Moselle River. The next 25 days would prove to be deadly for the 5th Infantry Division in trying to establish a bridgehead across the Moselle.



The first attempt to secure a bridgehead was made on September 7th, 1944 at Dornot, France. The 5th Division made a minor advance, but was forced to withdraw after 26 enemy

counterattacks. The attacking battalion lost 50 percent of their men in this attempt. Uncle Dick was wounded in this assault. As there were so many wounded, Dick refused treatment in favor of those more seriously wounded. But he died of blood loss the next day, September 8th, 1944. Posthumously promoted to Captain, he is buried in the Epinal American Cemetery in France.

My dad and my uncle Dick both volunteered to fight in World War II. Dad survived, but Dick did not. Uncle Dick was wounded on September 7, 1944. EXACTLY seven years later on September 7th, 1951, I was born. Until I researched facts for this article, I never knew the story. But now I can understand what compelled me to volunteer for the Army. I rose to the rank of Captain in the 101st Airborne Division. My uncle was promoted to Captain after his death. As Memorial Day 2017 approaches, please try to remember what this day is all about. It's not just "another day off work." People gave their lives for us to live in this great country.

COALITION FORMED TO ACCELERATE TRANSPORTATION IMPROVEMENTS ON I-25

Representatives from cities, counties, business and economic development interests up and down the I-25 corridor between Denver South and Colorado Springs announced the formation of the I-25 Gap Coalition to advocate for transportation improvements in the gap area between Castle Rock and Monument.

“Coalitions have been a successful model for obtaining transportation funding and advancing projects in Colorado,” said Douglas County Commissioner Roger Partridge. “We are committed to doing what is required to organize like-minded leaders to find a construction-funding solution so that we can meet our 2019 ground-breaking commitment.”

In January, CDOT announced plans to accelerate the environmental and planning process to have a project ready for construction by summer 2019 – with a project fully constructed between Castle Rock to Monument in five years – if funding is identified for construction. The Coalition hopes to assist in identifying funding sources and financing mechanisms to advance project implementation that improve safety and trip time reliability and provide much needed relief to traffic congestion.

“Widening I-25 between Monument and Castle Rock must be a

very high priority for the State of Colorado, as both an economic catalyst and safety improvement,” noted Colorado Springs Mayor John Suthers. “I commend CDOT for its commitment to accelerating the timeline on this vital project and encourage the Colorado Legislature to find an equitable funding mechanism for this and other major state transportation initiatives.”

BEAR WISE

Howdy, Folks. Beary Bear here. Hope you all had a relaxing Easter holiday and are enjoying the wonderful spring weather. Because we bears are up and about, be extra bear aware when entering garages, outbuildings and walking around blind corners on your property. Practice your “The Voice” blind audition song out loud when outside. You may not get a four-chair turn, but you will help ensure your safety so you



can sing another day.

New study challenges bear behavior beliefs

A six-year study of our statewide black bear population by the Colorado Parks and Wildlife department is challenging decades old assumptions about bear encounters with humans.

Wildlife researchers concluded that increasing bear-human conflicts do not mean the bear population is growing or that we bears are becoming more aggressive. Warmer temperatures have shortened our hibernation time, so we are more active later in the fall and earlier in the spring. But even with less sleep, we are still generally in a good mood.

There is some compelling new evidence that supports a trend that our population is actually declining. In southwestern Colorado around Durango, where researchers studied 617 bears starting in 2011, the female bear population decreased by 60 percent! Colorado’s bear population could decline even faster statewide if current trends and practices continue.

It is hard to obtain an accurate update on the Colorado black bear population, mainly because we don’t sit still. Best guess is about 17,000 statewide if you count my cousin Vinny who spends half the year in Colorado and the other half in New Mexico. The population of people in Colorado, by any measure, is increasing rapidly. To co-exist harmoniously, being Bear Wise is more important than ever.

You are seeing us more not because there are more of us, but because there are more of you living in and exploring areas we call home.

Researchers also recently observed that we black bears who dine on your garbage may not become addicted to it as previously believed. The team determined that bears eat human food when necessary (or easily available) to boost their weight for reproduction and hibernation, but switch back to their natural diet when possible. Of course, this doesn't explain why I obsess over pasta leftovers and will stroll right past a pile of acorns for an uneaten portion of Mamma Rosa's frozen lasagna in the bottom of your garbage can. I figure the nuts will always be there, the pasta... not so much.

However, the common belief that we bears may not be able to rehab ourselves to eat a natural bear diet once we have dined on yours is being questioned due to recent study results. This new evidence is challenging the current two-strikes policy of euthanizing "food-conditioned" bears. Currently, Colorado Parks and Wildlife follows a "two-strike" policy of tagging and relocating them once; second offenders can be killed. For the record: personally, I'm all for a change to a three-strike policy like in baseball. Or maybe even five fouls before being benched like in basketball.

What can you do to help?

- Bear guard your garbage and other food sources like there is a reward for it, because there is. Knowing that you are keeping us healthier and safer is reward in itself. During the recent bear study, Colorado Parks & Wildlife officials worked with Durango officials to put bear-proof trash cans at homes in some neighborhoods. They found that this reduced bear-human conflicts. In areas without bear-proof cans, conflicts increased sharply.

- Do not feed us intentionally; it's the law. Report offenders to the Colorado Parks and Wildlife Division and local law enforcement agencies.



- When you see us close to your home, make as much noise as possible to scare the scat out of us so we run away. It's important to our mutual safety that we are as fearful of you as you are of us.

Many of you have reported purchasing "bear proof" garbage containers this year. Thank you for investing in our mutual safety and helping keep us black bears healthier. For you bear proof container hold outs; you may see more bear activity as the number of easy food targets continues to decrease in your neighborhood.

I look forward to seeing you soon... from a good safe distance.

Officially! And we managed to squeeze in a few life-giving snowstorms for the trees and vegetation that sustain life, AND the first hummingbird right after the toad flax bloomed, April 2nd. The earliest I have seen for the toad flax. My tried and true observance is that within one or two days of the toad flax blooming, we have hummingbirds return.

I scrambled to make hummer food (recall – 1 cup of sugar to 4 cups of water, dissolved well - forget the red dye stuff.)

The next day we had a heavy snow storm. It melted quickly and the toad flax bounced right back, followed by two more storms.

The next week started the hummer sightings in the Palmer Lake area. It took still another week for me to see our first. And curiously it was a female broadtail. In the past for over 20 years, it has been a male scout, getting in position to welcome the babes.

The birdy version of the Mormon Tabernacle Choir, the wildflowers popping, our Dutch tulips we bought at the Keukenhof gardens in the Netherlands emerging in their new flower bed, just for them, the fragrant Oriental lilac already budding...Wow! This is my euphoria!

The koi are active, being primed for mating season. Too bad there are not enough left to do proper mating. Dang raccoons, and all they did is eat the brains of each fish before discarding it.

I will have to say back east in the D.C. area, fall was my favorite season. Taking walks where the crunch and smell of fallen leaves invigorated me. The temperate season is much longer there. The fall relieves the heat and humidity of the summer

and fall is welcomed, whereas here, the fall here can be so brief, and I do not look forward to the too-long winter weather soon to come.

Those Peckers

Woodpeckers of many species have been a curse to many a home owner. And they can be like squirrels: once they have invaded the homestead to bear their young, you will see them forever. I have transported squirrels to at least two miles away. With a Have-a-Heart trap, I carry them off to the Bear Dance Golf Course and let them go in front of the restaurant. Perfect. A few months ago, I told about the author of One Bird at a Time, who had flickers peck through his outside wall and lay eggs. He put in a window on the inside wall to watch them. I am not quite ready to go there.

Usually stucco houses do not have the woodpecker problem that houses with wood siding do.

John Coats, a long-time neighbor in Perry Park East has been inundated with flickers and other woodpeckers. John and Carol's house is stucco.

The state of Washington put out the following information:
"1) **Drumming:** A flicker drums to communicate with a mate

or to proclaim its territory and attract a mate. This typically happens during the breeding season (mid-March to June), but may continue into July. For reasons that are not fully understood, drumming may also occur for a short time in the fall. Drumming is the most common reason for flickers to use buildings, and while it may be annoying, the bird's activity usually does not penetrate completely through wood siding. Flickers will return year after year to the same house because it works for them; they attract a mate this way. Thus, a flicker that has been using the same location for several years will be hard to move.

To discourage drumming, try a combination of the following strategies:

Scare the flicker by hanging strips of Mylar scare tape or floating Mylar party balloons in front of the area of activity (Fig. 6). When using scare tape, strengthen each strip by attaching a piece of duct tape or nylon packing tape to each end. Tack or nail one end to the outer end of the roof soffit, just under the gutter, and attach the other end to the side of the house. Before attaching the bottom, twist the tape 6 to 7 times and keep the tape loose enough to provide some slack. The slack and twisting are necessary to produce the shimmering effect. Apply these tape strands at parallel intervals of 2 to 3 feet.

You can also try hanging aluminum pie pans horizontally along

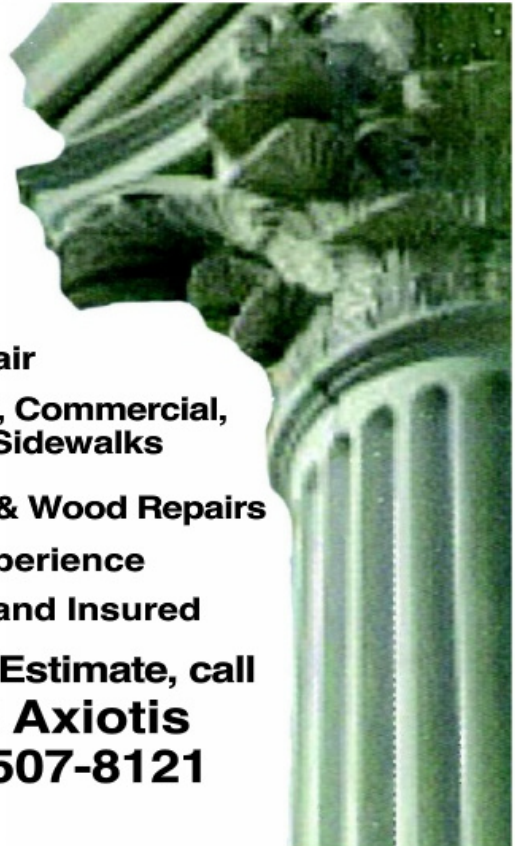
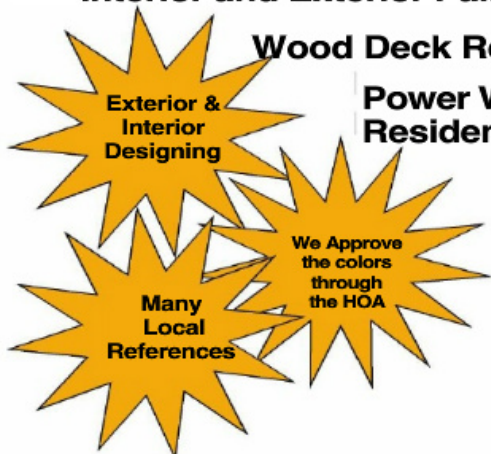

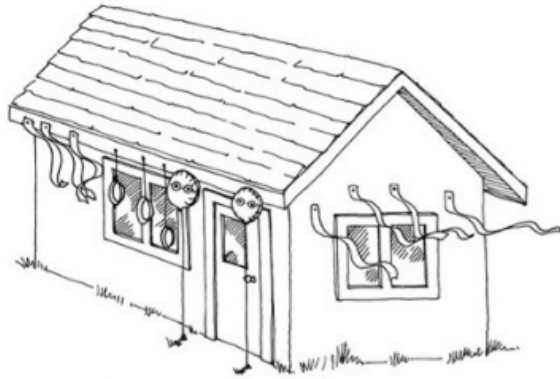

a rope or section of twine (Fig. 6). Run one end of the rope to a convenient window and fasten it to an object inside the house. Whenever you hear drumming, jerk on the string to make the pans move.



Some people have had success with stapling large rubber spiders in the vicinity of the drumming birds. Large, black rubber spiders are available from most party stores. The Birds Away Attack Spider® is vibration/sound activated and will respond to the drumming of woodpeckers, by dropping down on a “web” cord. Batteries then retract the spider back up the cord, where it waits for the next unsuspecting woodpecker to arrive.

Scaring the flicker by shouting and banging pans outside a nearby window may provide temporary relief. A squirt of water with a garden hose can have a similar effect. Again, flickers living in urban areas likely will have grown accustomed to such noises and activity, and the results will be short lived. (Note: Scaring flickers away from a nest containing eggs or young is illegal.)

Create a barrier by covering or wrapping the gutter, down-spout, or other drumming site with a sheet, tarp, burlap, or other material. A large area of siding can be protected by hanging a sheet, tarp, or bird netting from the roof gutter or eave (Fig. 7).

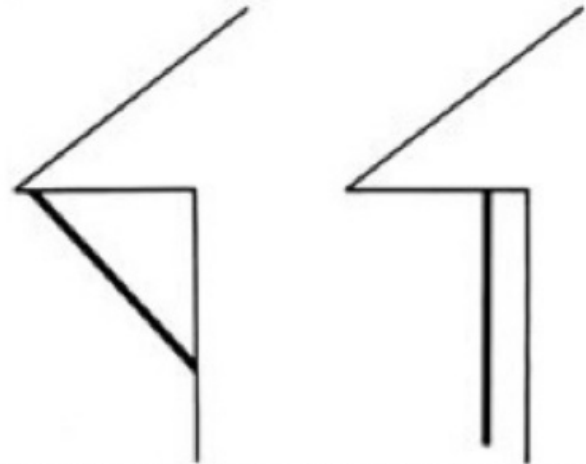
Be sure to cover any ledges or cracks the bird uses as a foothold while drumming. If you cannot fasten the material to the gutter or eave, attach it to a board that has been temporarily fastened along the top of the wall.

If a single board on the house serves as a toehold, heavy monofilament fishing line or stainless steel wire can be tightly stretched approximately 2 inches above the landing site to prevent the flicker from perching.

Repel flickers by applying a commercially available, nontoxic woodpecker-protective coating spray where activity is taking place. The spray exudes an aromatic and taste deterrent when pecked.

Note: A house decorated with these deterrents may attract the ire of the HOA.

Having been on a canoe camping trip to the border of Maine and New Hampshire, I can attest to the drumming of the very large pileated woodpecker. Talk about waking the dead. One of these birds had us hunkering down in our sleeping bags to block out the mega jackhammer noise outside our tent.

That’s all, folks, for this month. Gotta run. The first bird of the season has literally come down the chimney of our wood stove. I can’t see the red wings on this blackbird for all the soot he has accumulated.
